The undersigned is informed and believes that:

COUNT 1

On or about August 1, 2020, in the above named judicial district, the crime of ASSAULT UPON PEACE OFFICER OR FIREFIGHTER, in violation of PENAL CODE SECTION 245(c), a felony, was committed by Andres Ballesteros Medina, who did willfully and unlawfully commit an assault with a deadly weapon and instrument and by force likely to produce great bodily injury upon the person of Robert Boyd when said defendant(s) Andres Ballesteros Medina knew and should have known that said person was a peace officer then and there engaged in the performance of his/her duties .

On or about August 1, 2020, in the above named judicial district, the crime of POSSESSION OF A BILLY, BLACKJACK, ETC, in violation of PENAL CODE SECTION 22210, a felony, was committed by Andres Ballesteros Medina, Michael Anthony Nunez and Gilbert Lee Nunez, who did unlawfully manufacture, cause to be manufactured, import into the State of California, keep for

sale, offer and expose for sale, and give, lend, and possess an instrument and weapon of the kind commonly known as a blackjack, slungshot, billy, sandclub, sap, and sandbag.

It is further alleged pursuant to Penal Code sections 1170.12(a) through (d) and 667(b) through (i) as to count(s) 2 that said defendant(s) Michael Anthony Nunez, has suffered the following prior conviction of a serious or violent felony or juvenile adjudication:
