The undersigned is informed and believes that:

COUNT 1

On or about August 17, 2020, in the above named judicial district, the crime of INJURING A SPOUSE, COHABITANT, FIANCE, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Jacob Matthew Anderson, who willfully inflicted corporal injury resulting in a traumatic condition upon Athena Vae Staggs , who was someone with whom the defendant had a dating relationship.

COUNT 2

On or about August 17, 2020, in the above named judicial district, the crime of FALSE IMPRISONMENT BY VIOLENCE, in violation of PENAL CODE SECTION 236, a felony, was committed by Jacob Matthew Anderson, who did unlawfully violate the personal liberty of Athena Vae Staggs , said violation being effected by violence, menace, fraud, and deceit.

COUNT 3

On or about June 8, 2020, in the above named judicial district, the crime of INJURING A SPOUSE, COHABITANT, FIANCE, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Jacob Matthew Anderson, who willfully inflicted corporal injury resulting in a traumatic condition upon Athena Vae Staggs , who was someone with whom the defendant had a dating relationship.
