COUNT 1

On or about August 25, 2020, in the above named judicial district, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of PENAL CODE SECTION 261.5(c), a felony, was committed by Donovan Paul Bowin, who engaged in an act of unlawful sexual intercourse with Jane Doe, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.
