The undersigned is informed and believes that:

COUNT 1

On or about September 20, 2020, in the above named judicial district, the crime of BATTERY WITH INJURY ON A PEACE OFFICER, in violation of PENAL CODE SECTION 243(c)(2), a felony, was committed by John Franklin Coole, who did unlawfully use force and violence and inflict an injury upon the person of Tyler James Loup when said defendant(s) John Franklin Coole knew and reasonably should have known that said person was a peace officer then and there engaged in the performance of duty.

On or about September 20, 2020, in the above named judicial district, the crime of RESISTING EXECUTIVE OFFICER, in violation of PENAL CODE SECTION 69, a felony, was committed by John Franklin Coole, who did unlawfully attempt by means of threats and violence to deter and prevent Tyler James Loup , who was then and there an executive officer, from performing a duty imposed upon such officer by law, and did knowingly resist by the use of force and violence said executive officer in the performance of his/her duty.
