The undersigned is informed and believes that:

COUNT 1

On or about November 17, 2020, in the above named judicial district, the crime of ASSAULT UPON PEACE OFFICER OR FIREFIGHTER, in violation of PENAL CODE SECTION 245(c), a felony, was committed by Carol Elaine Sullivan, who did willfully and unlawfully commit an assault with a deadly weapon and instrument and by force likely to produce great bodily injury upon the person of Jonathan Arden when said defendant(s) Carol Elaine Sullivan knew and should have known that said person was a peace officer then and there engaged in the performance of his/her duties .
