The undersigned is informed and believes that:

COUNT 1

On or about November 22, 2020, in the above named judicial district, the crime of ASSAULT ON A CHILD CAUSING DEATH, in violation of PENAL CODE SECTION 273ab(a), a felony, was committed by Santos Guerrero Rodriguez, who did unlawfully, having care and custody of John Doe, a child under the age of 8 years, assault that child by means of force that to a reasonable person would be likely to produce bodily injury, resulting in the child's death.

On or about November 22, 2020, in the above named judicial district, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a felony, was committed by Santos Guerrero Rodriguez, who did unlawfully, and with malice aforethought murder John Doe, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."
