The undersigned is informed and believes that:

COUNT 1

On or about December 23, 2018, in the above named judicial district, the crime of CONTACT WITH MINOR FOR SEXUAL OFFENSE, in violation of PENAL CODE SECTION 288.3(a), a felony, was committed by Jason James Bemowski, who did unlawfully contact and communicate with a minor Jane Doe, knowing that Jane Doe was a minor, with the intent to commit an offense specified in Penal Code Section 207, 209, 261, 264.1, 273a, 286, 288, 288.2, 287, 289, 311.1, 311.2, 311.4, and 311.11 involving Jane Doe.

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime."

COUNT 2

On or about December 23, 2018, in the above named judicial district, the crime of UNLAWFUL SEXUAL INTERCOURSE, in violation of PENAL CODE SECTION 261.5(c), a felony, was committed by Jason James Bemowski, who engaged in an act of unlawful sexual intercourse with Jane Doe, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.

"NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of the jail or prison facility where you are incarcerated pursuant to Penal Code Section 1524.1 and Health and Safety Code section 121055 following a probable cause hearing resulting in a court order."

If so, these materials are disclosed to you pursuant to Penal Code section 1054.2 which provides: "No attorney may disclose or permit to be disclosed to a defendant the address or telephone number of a victim or witness whose name is disclosed to the attorney pursuant to subdivision (a) of Section 1054.1 unless specifically permitted to do so by the court after a hearing and a showing of good cause."
