The undersigned is informed and believes that:

## COUNT 1

On or about January 10, 2021, in the above named judicial district, the crime of ASSAULT BY MEANS OF FORCE LIKELY TO PRODUCE GREAT BODILY INJURY, in violation of PENAL CODE SECTION 245(a)(4), a felony, was committed by Chad Evan Young, who committed an assault on the person of Rudy Esperanza Ruvalcaba by means of force likely to produce great bodily injury.

It is further alleged as to count(s) 1, 2 that in the commission and attempted commission of the above offense, the said defendant(s) Chad Evan Young, personally used a firearm(s), to wit: BLACK 9MM HANDGUN, within the meaning of Penal Code sections 1203.06(a)(1) and 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

It is further alleged, within the meaning of Penal Code section 12022.7(e), as to count(s) 1, 2 that in the commission of the above offense, the said defendant(s) Chad Evan Young, personally inflicted great bodily injury upon Rudy Esperanza Ruvalcaba , under circumstances involving domestic violence.

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

### COUNT 2

\*\*\*\*\*

On or about January 10, 2021, in the above named judicial district, the crime of INJURING A SPOUSE, COHABITANT, FIANCE, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Chad Evan Young, who willfully inflicted corporal injury resulting in a traumatic condition upon Rudy Esperanza Ruvalcaba, who was someone with whom the defendant had a dating relationship.

It is further alleged as to count(s) 1, 2 that in the commission and attempted commission of the above offense, the said defendant(s) Chad Evan Young, personally used a firearm(s), to wit: BLACK 9MM HANDGUN, within the meaning of Penal Code sections 1203.06(a)(1) and 12022.5(a) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8) and a violent felony within the meaning of Penal Code section 667.5(c)(8).

It is further alleged, within the meaning of Penal Code section 12022.7(e), as to count(s) 1, 2 that in the commission of the above offense, the said defendant(s) Chad Evan Young, personally inflicted great bodily injury upon Rudy Esperanza Ruvalcaba , under circumstances involving domestic violence.

"NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)."

Pursuant to Evidence Code Section 1109, the People will move to admit evidence consistent with the defendant's rap sheet and law enforcement reports.

#### COUNT 3

On or about January 10, 2021, in the above named judicial district, the crime of HAVING A CONCEALED FIREARM IN A VEHICLE-NOT REGISTERED, in violation of PENAL CODE SECTION 25400(a)(1), a felony, was committed by Chad Evan Young, who did unlawfully carry concealed within a vehicle which was under his/her control and direction a pistol, revolver and firearm capable of being concealed upon the person. It is further alleged, pursuant to Penal Code section 25400(c)(6) that the firearm was loaded, and the unexpended ammunition were in the immediate possession of, and readily accessible to, the defendant and that the firearm was not registered to the defendant.

#### COUNT 4

\*\*\*\*\*

On or about January 10, 2021, in the above named judicial district, the crime of CARRYING LOADED HANDGUN ON ONE'S PERSON OR IN A VEHICLE-NOT REGISTERED, in violation of PENAL CODE SECTION 25850(a), a felony, was committed by Chad Evan Young, who did unlawfully carry a loaded handgun on the person and in a vehicle while in a public place and on a public street in an incorporated city and in a prohibited area of unincorporated territory.

It is further alleged, pursuant to Penal Code section 25850(c)(6) that said handgun was not registered to the defendant.

#### COUNT 5

On or about January 10, 2021, in the above named judicial district, the crime of RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT, in violation of PENAL CODE SECTION 148(a)(1), a misdemeanor, was committed by Chad Evan Young, who did willfully and unlawfully resist, delay and obstruct Tarron Broadway who was then and there a peace officer attempting to and discharging the duty of his/her office and employment.
