The undersigned is informed and believes that:

COUNT 1

On or about February 9, 2021, in the above named judicial district, the crime of INJURING A SPOUSE, COHABITANT, FIANCE, BOYFRIEND, GIRLFRIEND OR CHILD'S PARENT, in violation of PENAL CODE SECTION 273.5(a), a felony, was committed by Jason Michael Halcomb, who willfully inflicted corporal injury resulting in a traumatic condition upon Jane Doe, who was the defendant's cohabitant.

It is further alleged as to count(s) 1 that in the commission of the above offense the said defendant(s) Jason Michael Halcomb, personally inflicted great bodily injury upon Jane Doe, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8) and a violent felony within the meaning of Penal Code Section 667.5(c)(8).

On or about February 11, 2021, in the above named judicial district, the crime of ASSAULT WITH A DEADLY WEAPON, in violation of PENAL CODE SECTION 245(a)(1), a felony, was
