The undersigned is informed and believes that:

COUNT 1

On or about March 14, 2021, in the above named judicial district, the crime of MURDER, in violation of **PENAL CODE SECTION 187(a)**, a felony, was committed by **Luis Sanchez Jr aka "Sylent"**, who did unlawfully, and with malice aforethought murder Margarito Villasenor, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

It is further alleged pursuant to **Penal Code section 186.22(b)(1)(C)** as to count 1 that the above offense was committed for the benefit of, at the direction of, and in association with a criminal street gang, **El Sereno**, with the specific intent to promote, further and assist in criminal conduct by gang members. Said act also caused the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(28).

"NOTICE: Conviction of this offense will require you to register pursuant to Penal Code Section 186.30(a). Willful failure to register is a crime."

It is further alleged as to count 1 that said defendant **Luis Sanchez Jr aka "Sylent"**, personally and intentionally discharged a firearm, a handgun, which proximately caused great bodily injury and death to Margarito Villasenor within the meaning of Penal Code section 12022.53(d).

COUNT 2

On or about March 14, 2021, in the above named judicial district, the crime of POSSESSION OF FIREARM BY A FELON, in violation of PENAL CODE SECTION 29800(a)(1), a felony, was committed by **Luis Sanchez Jr aka "Sylent"**, who did unlawfully possess and have custody and control of a firearm, to wit, a handgun, the said defendant having been convicted of a felony under the laws of the United States, the state of California and any other state, government and county:
