The undersigned is informed and believes that:

COUNT 1

On or about March 12, 2021, in the above named judicial district, the crime of BATTERY WITH INJURY ON A PEACE OFFICER, in violation of PENAL CODE SECTION 243(c)(2), a felony, was committed by Linda Louise Briones, who did unlawfully use force and violence and inflict an injury upon the person of Deputy Matthew Alexander Izquierdo when said defendant, Linda Louise Briones, knew and reasonably should have known that Deputy Matthew Alexander Izquierdo was a peace officer then and there engaged in the performance of a duty.
