The undersigned is informed and believes that:

COUNT 1

On or about April 25, 2021, in the above named judicial district, the crime of POSSESSION OF FIREARM BY A FELON, in violation of PENAL CODE SECTION 29800(a)(1), a felony, was committed by Anthony Camacho, who did unlawfully own, purchase, receive, possess, and have custody and control of a firearm, to wit, Handgun, the said defendant(s) having been convicted of a felony under the laws of the United States, the state of California and any other state, government and county:

## COUNT 2

On or about April 25, 2021, in the above named judicial district, the crime of UNLAWFUL POSSESSION OF AMMUNITION, in violation of PENAL CODE SECTION 30305(a)(1), a felony, was committed by Anthony Camacho, who did own, possess, and have under his control ammunition and reloaded ammunition.

It is further alleged that the defendant is prohibited from owning and possessing a firearm pursuant to Chapter 2 and 3 of Division 9 of the Penal Code and sections 8100 and 8103 of the Welfare and Institutions Code, having been previously convicted of the following offense(s):

## COUNT 3

On or about April 25, 2021, in the above named judicial district, the crime of OWNING A HANDGUN NOT BEARING A SERIAL NUMBER, UNIQUE SERIAL NUMBER OR OTHER MARK OF ID, in violation of PENAL CODE SECTION 29180(c), a misdemeanor, was committed by Anthony Camacho, who who, as of July 1, 2018, did unlawfully own a firearm, to wit: HANDGUN, that did not bear a serial number assigned to it pursuant to Penal Code section 23910 and Chapter 44 (commencing with Section 921) of Part 1 of Title 18 of the United States Code and the regulations issued pursuant thereto, and a unique serial number and other mark of identification issued by the Department of Justice and affixed to the firearm pursuant to Penal Code section 29182 with notification of that fact being made thereto.

COUNT 4

On or about April 25, 2021, in the above named judicial district, the crime of RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT, in violation of PENAL CODE SECTION 148(a)(1), a misdemeanor, was committed by Anthony Camacho, who did willfully and unlawfully resist, delay and obstruct A Valdez, who was then and there a peace officer attempting to and discharging the duty of his/her office and employment.
