1 Plaintiff, the People of the State of California, by and through its attorneys: Ronald J. Freitas,
2 District Attorney of San Joaquin County; Jason Anderson, District Attorney of San Bernardino
3 County; and Jeff W. Reisig, District Attorney of Yolo County (the "People"), and Defendants Dollar
4 Tree Stores, Inc., Dollar Tree Distribution, Inc., and Family Dollar, LLC (hereinafter "Defendants"),
5 generally appearing through their attorney John J. Powers of Faegre Drinker Biddle & Reath LLP,
6 hereby stipulate and agree as follows:

7 1. The Court may enter this Stipulation for Entry of Final Judgment and Injunction
8 ("Final Judgment") before the taking of any proof and without trial or adjudication of any fact or law.

9 2. The Court has subject matter jurisdiction over the matters alleged in this action and
10 personal jurisdiction over the People and Defendants (collectively, "the Parties") to the Final
11 Judgment.

12 3. This Final Judgment is a fair and reasonable resolution of the matters alleged in the
13 People's Complaint.

14 4. Entry of this Final Judgment is not an admission or denial by Defendants regarding
15 any issue of law or fact in the above-captioned matter or any violation of law.

16 5. This Final Judgment shall be binding upon the People and upon Defendants; and

17 6. The Parties waive any right to set aside the Final Judgment through any collateral
18 attack, and further waive their right to appeal from the Final Judgment.

19 **NOW THEREFORE**, the People and Defendants having requested this Court to enter this
20 Final Judgment, and the Court having considered the Final Judgment reached between the parties, **IT**
21 **IS HEREBY ORDERED, ADJUDGED, AND DECREED** as follows:

22 **JURISDICTION AND VENUE**

23 1. The Superior Court of California, County of San Joaquin, has subject matter
24 jurisdiction over the matters alleged in this action and personal jurisdiction over the parties to this
25 Final Judgment.

26 **SETTLEMENT OF DISPUTED CLAIMS**

27 2. This Final Judgment is a fair and reasonable resolution of the Covered Matters (as
28 defined in Paragraph 12 below) and is in the best interest of the public.

1 **INJUNCTIVE RELIEF**

2 3. Pursuant to Business and Professions Code section 17203, Defendants and their
3 respective successor corporations or assignees are enjoined in California from selling or offering for
4 sale an over-the-counter drug after the expiration date in violation of Health and Safety Code section
5 110286.

6 **MANDATORY INJUNCTIVE PROVISIONS**

7 4. For a period of three (3) years from the Effective Date, Defendants shall dedicate a
8 minimum of four (4) employee hours, on a monthly basis, or an equivalent time, to verify the
9 expiration dates for over-the-counter drugs available for sale (“Expiration Sweep”) at each store
10 listed in Exhibit A or subsequently owned and/or operated by Defendants. If the expiration date is
11 set to expire within thirty (30) days, Defendants agree to remove any such items and dispose of them
12 as required by law. Notwithstanding the foregoing, Defendants may explore and evaluate enhanced
13 Expiration Sweep programs, computer-based, electronic, or other technology or modified assessment
14 systems (“Enhanced System”) to support the prevention of the sale of expired over-the-counter drugs
15 at each store listed in Exhibit A or subsequently owned and/or operated by Defendants during the
16 three (3) year Expiration Sweep period. Subject to Defendants’ written notice to and obtained
17 consent from the People, Defendants may opt to replace or supplement the Expiration Sweep with a
18 commensurate Enhanced System.

19 **CIVIL PENALTIES AND COST RECOVERY**

20 **Civil Penalties**

21 5. Defendants must pay TWO MILLION, FOUR HUNDRED FORTY-FOUR
22 THOUSAND AND FIFTY DOLLARS (\$2,444,050.00) as civil penalties pursuant to Business and
23 Professions Code section 17206, as set forth in Exhibit B.

24 **Cost Recovery**

25 6. Defendants must pay THREE HUNDRED AND FIFTY THOUSAND DOLLARS
26 (\$350,000.00) for reimbursement of costs of investigation and other costs of enforcement, as set forth
27 in Exhibit C.

28 ///

1 **Restitution**

2 7. The Parties recognize the infeasibility of identifying injured consumers who may have
3 purchased expired over-the-counter drugs, the impracticality of providing direct restitution to said
4 consumers, and the disproportionate cost of making restitution to individual consumers, which would
5 far exceed the benefit consumers would gain. Hence, pursuant to Business & Professions Code
6 section 17203, Defendants shall pay, as *cy pres* restitution, ONE HUNDRED THOUSAND
7 DOLLARS (\$100,000.00) for the benefit of the People of the State of California, payable to the
8 Consumer Protection Prosecution Trust Fund, established in the case of People v. ITT Consumer
9 Financial Corporation (Alameda Superior Court Case No. 656038-0).

10 **Form of Payment**

11 8. The payment of all cost recovery and civil penalties set forth in paragraphs 5 and 6
12 above, shall be made by separate checks payable as provided in Exhibits B and C, and delivered to
13 the District Attorney's Office for the County of San Joaquin, Attention: Celeste Kaisch, Deputy
14 District Attorney, for distribution pursuant to the terms of this Final Judgment. Said payments shall
15 be made within thirty (30) days following the Effective Date, as defined herein.

16 9. The payment of *cy pres* restitution set forth in paragraph 7 above, shall be made
17 payable to the Consumer Protection Prosecution Trust Fund, and delivered to the District Attorney's
18 Office for the County of San Joaquin, Attention: Celeste Kaisch, Deputy District Attorney, for
19 distribution pursuant to the terms of this Final judgment. Said payment shall be made within thirty
20 (30) days following the Effective Date, as defined herein.

21 **ENFORCEMENT OF FINAL JUDGMENT AND PENALTIES**

22 10. The People may move this Court for additional relief for any violation of any
23 provision of this Final Judgment including, but not limited to, contempt, additional injunctive
24 provisions, or additional penalties consistent with the provisions of this Final Judgment. Unless
25 otherwise set forth herein, nothing in this Final Judgment limits the People's right to seek any other
26 relief or remedies provided by law, or limits Defendants' right to defend against any request of the
27 People for such other relief or remedies.

28 11. The Parties shall meet and confer at least 30 days prior to the filing of any application

1 or motion relating to this Final Judgment and shall negotiate in good faith in an effort to resolve any
2 dispute without judicial intervention. If the Parties are unable to resolve their dispute after meet-and-
3 confer discussion, any Party may move this Court seeking a resolution of that dispute by the Court.

4 **MATTERS COVERED BY THIS FINAL JUDGMENT**

5 12. This Final Judgment is a final and binding resolution and settlement of all claims,
6 violations, and causes of action that were or could have been asserted by the People based upon the
7 facts alleged in their Complaint against Defendants (“Covered Matters”).

8 13. Any claim, violation, or cause of action that is not a Covered Matter is a “Reserved
9 Claim.” Reserved Claims include, without limitation, any unknown violation, any violation that is
10 unrelated to a Covered Matter, any violation that occurs after the filing of this Final Judgment, and
11 any violation not set forth in the People’s Complaint. The People reserve the right to pursue any
12 Reserved Claim, and Defendants reserve their defenses against any Reserved Claim. Nothing in this
13 paragraph limits the People’s ability to enforce the terms of this Final Judgment.

14 14. In any subsequent action that the People may bring based on any Reserved Claim,
15 Defendants cannot assert that failing to pursue any Reserved Claim as part of this action constitutes
16 claim-splitting. This paragraph does not affect any statute of limitations, if any, which may be
17 applicable to any Reserved Claim, and does not prohibit Defendants from asserting any statute of
18 limitations or other legal or equitable defenses that may be applicable to any Reserved Claim.

19 15. Defendants cannot pursue any civil or administrative claims against the People or any
20 agency of the State of California, county or city in the State of California, or local agency
21 (collectively, “Agencies”), or against any of the People or Agencies’ officers, employees,
22 representatives, agents or attorneys, arising out of or related to any Covered Matter and arising
23 before entry of this Final Judgment; provided, however, that if any Agencies initiate separate claims
24 against Defendants, Defendants reserve any and all rights, claims, demands, and defenses against
25 such Agencies.

26 **TERMINATION OF INJUNCTION**

27 16. At any time after this Final Judgment has been in effect for five (5) years, and
28 Defendants have paid and expended all amounts required under the Final Judgment, Defendants may

1 move to terminate the injunctive provisions in Paragraph 4 pursuant to Code of Civil Procedure
2 section 533 and Civil Code section 3434. After this Final Judgment has been in effect for seven (7)
3 years, and Defendants have paid and expended all amounts required under the Final Judgment, the
4 injunctive provisions in Paragraph 4 will terminate automatically.

1 18. Any party may change its notice name and address by informing the other parties in
2 writing, but no change is effective until it is received. All notices and other communications required
3 or permitted under this Final Judgment that are properly addressed as provided in this paragraph are
4 effective upon delivery if delivered personally or by overnight mail, or are effective five (5) days
5 following deposit in the United States mail, postage prepaid, if delivered by mail, or the day that
6 electronic mail is sent if sent before 5 p.m. to the electronic mail addresses of the designated
7 recipients for notice concurrent with sending the notice by overnight mail.

8 **EFFECT OF FINAL JUDGMENT**

9 19. Except as expressly provided in this Final Judgment, nothing in this Final Judgment is
10 intended nor may it be construed to preclude the People from exercising their authority under any
11 law, statute, or regulation. Defendants retain all of their defenses to the People's exercise of the
12 aforementioned authority.

13 **FUTURE REGULATORY CHANGES**

14 20. Nothing in this Final Judgment excuses Defendants from meeting any more-stringent
15 requirement that may be imposed by applicable law or by any change in the applicable law. To the
16 extent any future statutory or regulatory change makes Defendants' obligations less stringent than
17 those provided for in this Final Judgment, Defendants' compliance with the changed law will be
18 deemed compliance with this Final Judgment.

19 **NO WAIVER OF RIGHT TO ENFORCE**

20 21. The People's failure to enforce any provision of this Final Judgment may neither be
21 deemed a waiver of such provision nor in any way affect the validity of this Final Judgment. The
22 People's failure to enforce any such provision does not preclude them from later enforcing the same
23 or any other provision of this Final Judgment. Except as expressly provided in this Final Judgment,
24 Defendants retain all defenses allowed by law to any such later enforcement.

25 **PAYMENT OF LITIGATION EXPENSES AND FEES**

26 22. Defendants shall pay their own attorney fees, expert witness fees and costs, or any
27 other costs of litigation or investigation incurred to date.

28 ///

1 **INTERPRETATION**

2 23. The Final Judgment was drafted equally by all Parties hereto. Accordingly, any and
3 all rules of construction including Civil Code section 1654, which provides that ambiguity is
4 construed against the party causing the uncertainty, shall not apply to the interpretation of this Final
5 Judgment.

6 **INTEGRATION**

7 24. This Final Judgment constitutes the entire agreement between the parties and may not
8 be amended or supplemented except as provided for herein. No oral advice, guidance, suggestions or
9 comments by employees or officials of any Party shall be construed to relieve any Party of its
10 obligations under this Final Judgment. No oral representations have been made or relied upon other
11 than as expressly set forth herein.

12 **INCORPORATION OF EXHIBITS**

13 25. Exhibits "A", "B", and "C" are incorporated herein by reference.

14 **CONTINUING JURISDICTION**

15 26. The Court will retain continuing jurisdiction to enforce the terms of this Final
16 Judgment and to address any other matters arising out of or regarding this Final Judgment.

17 **MODIFICATION**

18 27. This Final Judgment may be modified only upon written consent by all of the parties
19 and the approval of the Court.

20 **EFFECTIVE DATE**

21 28. The Effective Date of this Final Judgment is the date of the signature of the Court
22 entering this Final Judgment.




