3 (collectively "the People") and Defendant CELLCO PARTNERSHIP d/b/a VERIZON
4 WIRELESS, a Delaware Corporation ("Defendant") generally appearing by and through their
5 attorney, Collie F. James, Morgan, Lewis & Bockius LLP, have stipulated to the entry of this
6 Final Judgment.

7 For purposes of this Stipulation, the People and Defendant shall be referred to collectively
8 as "Parties."

9 **IT IS HEREBY STIPULATED** and agreed as follows:

10 1. This Court may enter the proposed Final Judgment and Injunction Pursuant to
11 Stipulation (hereinafter "Final Judgment"), a copy of which is attached hereto and incorporated
12 herein as "Exhibit 1" before the taking of any proof and without trial or adjudication of any fact
13 or law.

14 2. Plaintiff may submit the proposed Final Judgment to any judge of the Superior
15 Court of the State of California, County of Orange, for approval and signature based upon this
16 Stipulation for Entry of Final Judgment and Injunction on an *ex parte* basis, without notice to or
17 any appearance by Defendant.

18 3. The Parties are generally appearing before the Superior Court of California,
19 County of Orange, which has subject matter jurisdiction over the matters alleged in this action
20 and personal jurisdiction over the Parties to this Final Judgment.

21 4. Defendant represents and warrants that the execution and delivery of this
22 Stipulation are the Defendant's free and voluntary acts, that the Stipulation and the proposed
23 Final Judgment are the result of good faith settlement negotiations between the Defendant and
24 the People, and that the Defendant has been represented and advised by counsel at all such times.

25 5. The Parties' execution of this Stipulation is not intended to and shall not
26 constitute an admission nor a denial of wrongdoing or liability by Defendant.

1 6. Defendant agrees to be bound by the terms of this Stipulation and by the Final
2 Judgment as of the date of signature of their corporate officers below.

3 7. Defendant represents and warrants that the Defendant is the proper party to the
4 Final Judgment and that the corporate officer signing this Stipulation on behalf of the Defendant
5 is fully authorized to enter this Stipulation and legally bind the Defendant as of the date of
6 signatures below.

7 8. Defendant waives service of a summons and complaint and notice of entry of
8 judgment.

9 9. Prior to the filing of this Stipulation, Defendant will provide the People with a
10 check made payable to the "Orange County Superior Court" in the amount of \$435.00, which
11 will be deposited with the Clerk of the Court as Defendant's first appearance fees.

12 10. Defendant waives any right to appeal, to attempt to set aside or vacate, or
13 otherwise to attack, directly or collaterally, the Final Judgment entered pursuant to this
14 Stipulation, or any provision contained herein.

15 11. This Stipulation may be executed in counterparts and on multiple signature pages.
16 A copy of any signature, whether transmitted by mail, e-mail and computer scanning, or
17 facsimile, shall be as valid and binding as an original signature.

3 (collectively "the People") and Defendant CELLCO PARTNERSHIP d/b/a VERIZON
4 WIRELESS, a Delaware Corporation ("Defendant") generally appearing by and through their
5 attorney, Collie F. James IV, Morgan, Lewis & Bockius LLP, have entered into a Stipulation for
6 this Final Judgment and Injunction ("Stipulation") and have thereby agreed to entry of this Final
7 Judgment and Injunction ("Final Judgment") without the taking of proof and without the
8 Stipulated Final Judgment constituting evidence of an admission or a denial by any party
9 regarding any issue of fact or law alleged in the Complaint, and Defendant having waived the
10 right to appeal, and good cause appearing upon consent of the aforementioned Parties, **IT IS**
11 **HEREBY ORDERED, ADJUDGED, AND DECREED THAT:**

12 **JURISDICTION**

13 This action is brought under California law and this Court has jurisdiction over the
14 subject matter and over Plaintiff and Defendant (collectively "the Parties"). The Parties agree
15 that the Superior Court for the County of Orange is a proper venue for this action.

16 **DEFINITIONS**

17 1. Except where otherwise expressly defined in this Final Judgment, the definitions
18 set forth in the following statutory schemes and all regulations issued pursuant thereto, shall
19 apply to the technical terms used herein: (a) the Hazardous Materials Release Response Plans
20 and Inventory Law (California Health and Safety Code, Division 20, Chapters 6.95) (b) the
21 Aboveground Petroleum Storage Act Law (California Health and Safety Code, Division 20,
22 Chapters 6.67); and (c) section 17200 *et seq.* of the Business and Professions Code.

23 2. "Facility" or "Facilities" mean the locations within the State of California listed in
24 **Exhibit A** and any similar facility located in the SoCal Region Defendant acquires as owner or
25 operator subsequent to the Effective Date of this Final Judgment.

26 ///

3. "SoCal Region" means the geographical region encompassing Imperial, Los Angeles, Orange, Riverside, San Bernardino, San Diego, and Ventura Counties.

INJUNCTION

Applicability

4. The provisions of this injunction are applicable to the Defendant, its successors and assigns, agents, representatives, officers, directors, managers, subsidiaries, and to all persons, employees, and corporations and other entities acting under, by, through or on behalf of, or in concert with either Defendant with actual or constructive knowledge of this Final Judgment, with regard to the Facilities. Independent Contractors and subcontractors are not covered by this Final Judgment.

Compliance with Applicable Statutes, Regulations, and Permits

5. Pursuant to the provisions of Health and Safety 25515.6 and 25270.12 and Business and Professions Code Section 17203, Defendant is enjoined and restrained from violating Chapters 6.11, 6.95 and 6.67 of Division 20 of the Health and Safety Code and the regulations enacted pursuant to those Chapters.

Specific Injunctive Provisions

6. Pursuant to the provisions of Health and Safety Code sections 25515.6 and 25270.12 and Business and Professions Code Section 17203, Defendant is enjoined and restrained from failing to comply with any of the following legal requirements at any Facility:

Hazardous Materials Release, and Response Plan Requirements

a. Pursuant to Health and Safety Code section 25508, Defendant shall annually submit Hazardous Materials Business Plans (HMBP's or "business plans") to the California Environmental Reporting System (CERS) for each Facility that handles hazardous materials in or above the threshold quantities specified in California Code of Regulations, Title 19, section 5030.2 and maintain copies onsite as required by law. The submission shall include: the Business Activities page of the Unified Program Consolidated Form; the Hazardous

1 Materials-Chemical Description Page; an Annotated Site Map as required by California Code of
2 Regulations, Title 19, section 5030.3 and Health and Safety Code 25505(a)(2); and an
3 Emergency Response Plan as required by California Code of Regulations, Title 19, section
4 5030.9, 5030.3 and Health and Safety Code 25505(a)(3).

5 b. Defendant shall have a business plan for each applicable Facility
6 readily available to personnel of the business with responsibilities for emergency response or
7 training as required by Health and Safety Code section 25505(c).

8 c. Defendant shall establish and electronically submit an adequate
9 training program in safety procedures in the event of a release or threatened release of hazardous
10 material as required by Health and Safety Code sections 25505(a)(4), 25508(a)(1), 25508(a)(3),
11 and California Code of Regulations, Title 19, sections 5030.9 and 5030.10.

12 d. Defendant shall provide initial and annual training to all SoCal Region
13 employees, as applicable based on the position of each employee, in safety procedures in the
14 event of a release or threatened release of a hazardous material and document and maintain
15 training records for a minimum of three (3) years as required by Health and Safety Code section
16 25505(a)(4) and California Code of Regulations, Title 19, section 5030.10(b).

17 e. Defendant shall electronically update their Facility business plans
18 within thirty (30) days of any one of the following events: (1) one hundred percent or more
19 increase in quantity of previously disclosed material; (2) any handling of a previously
20 undisclosed hazardous materials at or above reportable quantities; (3) change of business
21 address, business ownership, or business name; or (4) a substantial change in the handler's
22 operations that requires modification to any portion of the business plan as required by Health
23 and Safety Code section 25508.1(a through f), 25505(a)(1), and 25507.

24 f. Defendant shall provide access to any employee or authorized
25 representative of a unified program agency who has the authority specified in Health and Safety
26 Code Section 25185, with respect to the premises of a Facility, for inspections concerning
27

1 hazardous material, in addition to hazardous waste as required by Health and Safety Code
2 Section 25511.

- 3 a. Such access will comply with related local ordinances, including but
4 not limited to:
- 5 i. Los Angeles Municipal Code section 57.104.3, 57.120.3,
6 57.105.3.9.6.1, and 57.105.3.9.6.3.
 - 7 ii. San Bernardino County Code section 23.0407.

8 **Aboveground Petroleum Storage Act Requirements**

9 g. Defendant shall pay the Aboveground Petroleum Storage Act program
10 fees, as applicable for any Facility, as required by Health and Safety Code 25270.6(b).

11 h. Defendant shall have a licensed professional engineer properly review
12 and certify the Spill Prevention Control and Countermeasure (SPCC) Plan for each applicable
13 Facility as required by Health and Safety Code section 25270.4.5(a).

14 i. Defendant is required to inspect each aboveground container for
15 integrity based on industry standards as discussed in the SPCC plan for each Facility per
16 California Code of Regulations, Title 40, Section 112 *et seq.*

17 **Unified Program Agency Fee**

18 j. Defendant shall pay the Unified Program Agency fees associated with
19 any Facility as required by Health and Safety Code 25513, 25501(e)(4), and 25404.1.1(k)(1); and
20 by all related local ordinances including:

- 21 i. Anaheim Municipal Code 6.11.160
- 22 ii. Los Angeles County Ordinance 12.50.075
- 23 iii. Los Angeles Municipal Code section 57.120.6
- 24 iv. Oxnard City Ordinance 11-303 and 11-336
- 25 v. Riverside County Ordinance 640
- 26 vi. San Bernardino County Code 23.0602(a)

1 c. The WNESD shall assist in the development and implementation of a
2 written compliance plan that shall include policies and procedures designed to ensure compliance
3 with the laws and regulations set forth in Paragraph 5 and all additional requirements set forth
4 herein at each Facility. The compliance plan shall include policies and procedures to facilitate
5 the timeliness of all required inspections and other requirements, including: timely payment of
6 all permit fees; fulfillment of all Facility employee training requirements; and the timely
7 demonstration of Defendant's return to compliance to regulatory agencies after any finding of
8 non-compliance.

9 d. The WNESD shall have access to all inspection reports in Defendant's
10 possession (including regulatory agency reports and those created by private contractors) relating
11 to all Facilities. Defendant shall take prompt action, commensurate with the circumstances, to
12 address any violation, failure of equipment, or concerns raised in any inspection report.

13 **Annual Environmental Inspection and Status Report**

14 e. No later than one year after the date of this Final Judgment, and every
15 year thereafter, the WNESD shall assess the effectiveness of Defendant's compliance with the
16 terms of this Final Judgment and shall author and submit to the persons listed in **Exhibit B** a
17 written report covering the twelve months preceding August 1 ("Status Report") that summarizes
18 the findings of the assessment, and sets forth any measures taken and/or planned by Defendant in
19 relation to compliance with this Final Judgment. The Status Report shall include a review of
20 inspection reports by any regulatory agency related to any Facility. The Status Report shall also
21 include a review of relevant documents relating to compliance, including but not limited to
22 payment of annual Facility permit fees, records documenting personnel training and forms
23 documenting inspection of Facility aboveground petroleum storage tanks. The Status Report
24 shall disclose any written notice of violation that Defendant has received pertaining to the
25 matters covered in this Final Judgment received in conjunction with a regulatory inspection or in
26 any other written Notice of Violation from any UPA or other environmental regulatory agency

1 related to a Facility or the SoCal Region. The Status Report shall document the cause of the
2 violation, all actions taken by Defendant in response to such violation, and any outstanding
3 compliance failures of which Defendant is aware. The Status Report may be submitted
4 electronically.

5 f. Each Status Report shall be signed by the WNESD. The certification
6 shall read, "Based on the combination of my personal knowledge and belief formed in reliance
7 on information provided to me, and after conducting reasonable inquiry, I declare under penalty
8 of perjury that the information contained in and accompanying this submission is true, accurate,
9 and complete." Each annual Status Report shall be completed and submitted to Plaintiff within
10 30 days following the above-described period.

11 **CIVIL PENALTIES, COSTS AND SEPS**

12 8. Upon entry of this Final Judgment, Defendant shall be liable for the total
13 settlement amount of SEVEN MILLION SEVEN HUNDRED THOUSAND DOLLARS
14 (\$7,700,000.00), to be paid as set forth below. All payments made pursuant to this Final
15 Judgment shall be made by separate checks to each the payees listed in **Exhibits C-1 (Civil**
16 **Penalties to Plaintiff), C-2 (Civil Penalties – Civil Penalties to Agencies), D (Cost Recovery),**
17 **and E (Supplemental Environmental Projects)** within 60 days of entry of this Final Judgment.
18 All payments shall be delivered to the Orange County District Attorney's Office, 300 N. Flower
19 Street, Seventh Floor, Santa Ana, CA 92703, to the attention of Deputy District Attorney Susan
20 Park, for distribution pursuant to the terms of this Final Judgment.

21 9. The People will report the Penalty Payments as penalties through an IRS Form
22 1098-F, pursuant to and consistent with 26 U.S.C. section 6050X. Therefore, Defendant shall
23 provide to the People (i) an IRS Form W-9 within 14 calendar days of entry of this Judgment,
24 and (ii) any other information the People reasonably require in fulfilling IRS reporting
25 obligations within seven days of the People's request.

a. Civil Penalties

Within sixty (60) days after entry of this Final Judgment Defendant shall pay SEVEN MILLION ONE HUNDRED TWENTY FIVE THOUSAND DOLLARS (\$7,125,000.00) as civil penalties to the entities identified in, and in accordance with, the terms of Exhibits C-1 and C-2, attached hereto and made a part of this Final Judgment by this reference.

b. Reimbursement of Costs of Investigation and Enforcement

Within sixty (60) days after entry of this Final Judgment, Defendant shall pay TWO HUNDRED THOUSAND (\$200,000.00) for reimbursement of costs of investigation, attorney's fees, and other costs of enforcement to the entities identified in, and in accordance with the terms of, Exhibit D, attached and made a part of this Final Judgment by this reference.

c. Supplemental Environmental Projects

Within sixty (60) days after entry of this Final Judgment, Defendant shall pay THREE HUNDRED AND SEVENTY-FIVE THOUSAND DOLLARS (\$375,000.00) for supplemental environmental projects identified in Exhibit E and in accordance with the terms in Exhibit E, attached and made a part of this Final Judgment by this reference.

ENFORCEMENT OF FINAL JUDGMENT

10. The People may move this Court for additional relief for violation of any provision of this Final Judgment, including but not limited to, contempt, additional injunctive remedies, or additional penalties. Nothing in this Final Judgment shall limit any rights of the People to seek any other relief or remedies provided by law.
11. The Court shall retain continuing jurisdiction to enforce the injunctive terms of this Final Judgment and to address any other matters arising out of or relating to the injunctive provisions of this Final Judgment.

MATTERS RESOLVED BY THIS FINAL JUDGMENT

12. This Final Judgment is a final and binding resolution and settlement of the claims, violations and causes of action occurring at the Defendant's Facilities listed in **Exhibit A** that are alleged by the People in the Complaint in this matter, which shall be known as "Covered Matters." Any claim, violation, or cause of action that is not a Covered Matter is a "Reserved Claim."

13. Reserved Claims include, without limitation: any violation that occurs after the filing of this Final Judgment; any claim, violation, or cause of action against independent contractors or subcontractors retained to do work for Defendant; and separate and independent violations arising out of matters or allegations that are not set forth in the Complaint, whether known or unknown.

14. This Judgment does not include claims or causes of action against Defendant for performance of cleanup, corrective action, or response action for any actual past or future releases, spills, or disposals of hazardous waste and/or substances for which either Defendant is a responsible party or otherwise liable. In any subsequent action that may be brought by the People based on any claim not resolved herein, Defendant agrees that they will not assert that failing to pursue such a claim as part of this action constitutes claim-splitting, laches or is otherwise inequitable or precluded because the claim should have been brought as part of this action.

15. Nothing in this Final Judgment is intended, nor shall it be construed to preclude the People, or any state, county, city, or local agency, department, board, or entity, or any UPA from exercising its authority under any law, statute, or regulation. Furthermore, nothing in this Final Judgment shall be construed to excuse Defendant from compliance with any applicable statutes, regulations, local ordinances or permitting requirements or any other law or applicable requirement.

16. Defendant covenants not to pursue any civil or administrative claims against the People or against any agency of the State of California, or any county or city in the State of

1 California, or any UPA, Participating Agency or local agency (collectively, "Agencies"), or
2 against any of their officers, employees, representatives, agents, or attorneys, arising out of or
3 related to any Covered Matter and arising before entry of this Final Judgment; provided,
4 however, that if any Agencies initiate claims against Defendant, Defendant retains any and all
5 rights and defenses against such Agencies.

6 **NO WAIVER OF RIGHT TO ENFORCE**

7 17. The failure of the People to enforce any provision of this Final Judgment shall
8 neither be deemed a waiver of such provision nor in any way affect the validity of this Final
9 Judgment. Except as expressly provided in this Final Judgment, the failure of the People to
10 enforce any such provision shall not preclude them from later enforcing the same or any other
11 provision of this Final Judgment, subject to Paragraphs 26 and 27. Except as expressly provided
12 in this Final Judgment, Defendant retains all defenses to any such later enforcement action.

13 18. No oral advice, guidance, suggestion or comment by employees or officials of any
14 Party regarding matters covered in this Final Judgment shall be construed to relieve any Party of
15 its obligations under this Final Judgment.

16 **FUTURE REGULATORY CHANGES**

17 19. Nothing in this Final Judgment shall excuse Defendant from meeting any more-
18 stringent requirement that may be imposed by applicable existing law or by any change in the
19 applicable law. To the extent any future statutory or regulatory change makes Defendant's
20 obligations less stringent than those provided for in this Final Judgment, Defendant's compliance
21 with the changed law shall be deemed compliance with this Final Judgment; however, any
22 change in law or regulation shall not reduce or diminish Defendant's obligations to comply with
23 Paragraph 6 above.

24 **NOTICES**

25 20. Unless otherwise specified in this Final Judgment, all notices under this Final
26 Judgment shall be made in writing, by both email and mail, and addressed to the persons

1 identified in **Exhibit B**. Any Party may, by written notice to the other Parties, change its
2 designated notice recipient or notice address.

3 **INCORPORATION OF EXHIBITS**

4 21. Exhibits "A" through "E" are incorporated herein by reference.

5 **MODIFICATION**

6 22. The injunctive provisions of this Final Judgment may be modified only on noticed
7 motion by one of the parties with approval of the Court, or upon written consent by all of the
8 Parties and the approval of the Court.

9 **ABILITY TO INSPECT AND COPY RECORDS AND DOCUMENTS**

10 23. Defendant shall permit any duly authorized representative of the People to inspect
11 and copy records and documents relevant to determine compliance with the terms of this Final
12 Judgment. This Paragraph shall not limit the People's authority to access or obtain information
13 records and documents pursuant to any other statute or regulation.

14 **PAYMENT OF LITIGATION EXPENSES AND FEES**

15 24. Defendant shall make no request of the People to pay Defendant's attorney fees,
16 expert witness fees and costs, or any other costs of litigation or investigation incurred to date.

17 **INTERPRETATION**

18 25. This Final Judgment was drafted by both Parties. The Parties agree that the rule
19 of construction holding that ambiguity is construed against the drafting party shall not apply to
20 the interpretation of this Final Judgment.

21 **TERMINATION OF INJUNCTION**

22 26. At any time after this Final Judgment has been in effect for five (5) years,
23 Defendant may move to terminate the injunctive provisions in Paragraphs 5, 6, and 7 pursuant to
24 Code of Civil Procedure section 533 and Civil Code section 3424 unless Defendant has failed to
25 pay and expend all amounts required under the Final Judgment. After this Final Judgment has
26 been in effect for seven (7) years, and Defendant has paid and expended all amounts required

1 under the Final Judgment, the injunctive provisions in Paragraphs 5, 6, and 7 will terminate
2 automatically.

3 **TERMINATION OF COMPLIANCE PROGRAM**

4 27. Defendant's obligations to engage in a compliance program pursuant to Paragraph
5 5 of this Final Judgment shall terminate five (5) years after the Effective Date of this Final
6 Judgment provided that Defendant has paid all amounts owed per **Exhibits C-1, C-2, D, and E.**

7 **EFFECTIVE DATE OF FINAL JUDGMENT**

8 28. This Final Judgment shall become effective upon entry and Notice of Entry of
9 Judgment is waived.

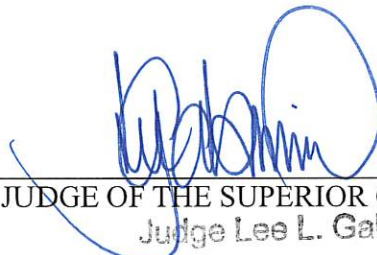

1. California CUPA Forum.²

Defendants shall provide the amount of One Hundred and Twenty-Three Thousand Seven Hundred and Fifty Dollars (\$123,750.00) payable to California CUPA Forum to fund scholarships for attendance and participation at the annual California Unified Program Annual Training Conference. Each of these scholarships shall cover conference registration, transportation, meals, and hotel at the training conference rate. Travel and per diem expenses will be reimbursed in accordance with the reimbursement policies of the "California CUPA Forum Board Training Conference Expense Reimbursement Policies", and any subsequent modifications thereto.

2. Western States Project.²

Defendants shall provide the amount of One Hundred and Twenty-Three Thousand Seven Hundred and Fifty Dollars (\$123,750.00) payable to the Western States Project, of which Ninety-Nine Thousand Dollars (\$99,000.00) to be used by the Western States Project for both remote and live trainings courses for current California Environmental Prosecutors and/or investigators/professional staff, and Twenty-Four Thousand and Seven Hundred and Fifty

(\$24,750) is to be used for the purposes of providing training consistent with the objectives of the Western States Project.

3. California Hazardous Material Investigators Association (CHMIA).²

4. California Advanced Environmental Criminal Training Program (Cal-AECTP) with CHMIA.²

Defendants shall provide the amount of Thirty-Seven Thousand Five Hundred Dollars (\$37,500.00) payable to the California Hazardous Materials Investigators Association ("CHMIA") to be used by CHMIA to fund full scholarships for attendance and participation in the Advanced Environmental Crimes Training Program. Each of these scholarships shall cover conference registration, travel, food, lodging, and incidentals.

5. Cal EPA – Environmental Enforcement and Training Account (PC§14300)²

Defendants shall provide the amount of Fifty-two Thousand Five Hundred Dollars (\$52,500.00) payable to the "Secretary for California Environmental Protection Agency" for deposit in the Environmental Enforcement and Training Account as set forth in Penal Code Section 14300 et seq., for purposes consistent with the mission of the Environmental Enforcement and Training

Act of 2002.
